EVERYONE HAS A PLACE IN THE WORLD OF MUSIC 2008 Competition

DIVERSONS is a competition organised by "la Caixa" Social Projects and is open to musicians who play ethnic and/or traditional music.

Conditions of entry:

- Competition open to music groups of 2 to 8 members, from any part of Spain.
- Preference will be given to the use of acoustic instruments and the interpretation of traditional music.
- Individual performers or groups selected for previous Diversons competitions are not eligible to apply.
- The jury will take into account the age of participants and the extent to which they are known by the public, and preference will be given to younger musicians who are less established in the music market.

"la Caixa" Foundation will offer those shortlisted:

- The chance for paid participation in the DIVERSONS concerts organised by "la Caixa" Foundation all over Spain.
- The opportunity to attend music fairs and other meetings with professional musicians.
- Administrative and artistic support.

Documentation required:

- A CD recording of at least 15 minutes duration which contains at least two pieces representative of the type of music played by the group.
- Name, address, passport number, DNI or NIE, telephone number, ages of all members of the group and an e-mail address for the group representative.
- List of names and instruments for each member of the group.
- Biography of the group or its members and press cuttings, where available.
- Digital photograph of the group.
- Technical information for the concert.
- Proposal/program for a 45-minute concert.

Failure to comply with these requirements may lead to the exclusion from the competition of the applicant group.
